

Privacy Notice Pursuant to the California Consumer Privacy Act

You have a right to request that we disclose to you what personal information we collect, use, disclose, or sell. To submit a request, you can contact us at our customer service number or in writing. You will be required to authenticate your identity by providing your full name and one or more of the following; address listed on the account, last four digits of the customer’s social security number/Tax ID, account number, last 6 of VIN, year/make/model of the vehicle, payment amount, payment date, or dealer name/number.

The following chart summarizes our use and collection of personal information in the preceding 12 months.
